# Increasing the value of e-invoices **with** **Medius Capture**

K-Bygg uses Medius AP Automation for managing supplier invoices. Recently, they also chose to implement Medius' automated data capture solution, Medius Capture.

If any data from the e-invoice had been entered into the wrong field, this led to unnecessary and time-consuming manual work for the accounts payable staff. They then had to cancel and modify the invoice in Medius and ask the e-invoice provider to change the template for data capture.



Thanks to Medius Capture, we can verify that the e-invoices have been captured correctly and easily correct any information that does not appear in the correct fields. This saves us a lot of time later in the process.

# Automated data capture **that gets smarter over time**

When the employees in the accounts payable department discover and correct an error in the data capture step,

the system learns after two corrections and then makes the correction automatically. When K-Bygg sees that invoices from one supplier have been captured correctly by Medius Capture, they can initiate automatic data capture for that supplier so that future invoices are captured in a fully automated process without any manual intervention.



When we have a new supplier, we usually only need to verify two invoices before we can turn on automatic capture in Medius Capture.
